**RURAL MUNICIPALITY of ABERDEEN No. 373  
BYLAW NO. 2020-04**

A bylaw to amend Bylaw No. 2007-05, known as the Zoning Bylaw of the Rural Municipality of Aberdeen No. 373.

The Council of the Rural Municipality of Aberdeen No. 373, in the Province of Saskatchewan, enacts this bylaw to amend Bylaw No. 2007-05 as follows:

1. **The Zoning District Map referred to in Section 5 - ZONING DISTRICTS** is amended as follows:
  - a) by rezoning from A-Agricultural to C1-Commercial/Industrial a portion of NE ¼ Section 15-38-03-W3M as shown on the attached map detail which is attached and forms part of this bylaw as "Schedule A"; and
  - b) by rezoning from A-Agricultural to C1(H)-Commercial/Industrial Holding the remainder of NE ¼ Section 15-38-03-W3M as shown on the attached map detail which is attached and forms part of this bylaw as "Schedule A".
2. This bylaw shall become effective on the date of approval of the Minister of Government Relations.


